Approximately 75% of the Yountville voters voted in favor of the affordable housing measure, so the community clearly supports this need. I would work to understand how the community and my neighbors feel the objectives can be best accomplished. I would bring to my representation my bent towards actionable, economic and practical approaches based on my business experience. I would also bring my interest in seeing a good balancing of the need for affordable housing and a diverse community with the goal of maintaining the beauty of the Yountville environment.

What strengths/expertise,special skills would you bring to the Board, Commission, or Committee?

My experience on the City of Orinda Planning Commission and legal experience have provided me with a working knowledge of the legal and policy framework for land use regulation which are part of furthering affordable housing. Having also served on the Rent Board for the City of Oakland, I developed an understanding of the problems that face both the people who need accessible and affordable housing and real property owners. After working as an attorney, I moved into a business management position at the University of California overseeing a large budget, and would bring the ability to understand budgets and financial information that would be part of the financial oversight role of this committee.
