Town of Yountville Resolution Number 19-3584

Adoption of Resolution Number 19-3584 Establishing Timed Parking Zones and Other Parking Management Improvements in Various Locations in Town.

Recitals

- A. At the July 16, 2019 Town Council meeting, Council conducted a parking workshop and directed staff to return with suggestion to better manage parking in the public Right of Way in Town.
- B. On July 18, 2017, the Town Council adopted Ordinance Number 17-463 prohibiting stopping, parking, or leaving vehicles upon streets which added section 10.28.220 to the Yountville Municipal Code.
- C. Section 10.28.020 of Chapter 10.28 of Title 10 of the Yountville Municipal Code makes it unlawful for any person to park a vehicle or cause, allow, or permit to be parked, a vehicle in any public parking space in violation of signs erected and/or pavement markings, and authorizes the removal of such vehicles in accordance with state law; and
- D. Yountville Municipal Code section 10.28.030 requires the Town Council by Resolution to establish parking prohibitions for public parking spaces in accordance with that Chapter; and Yountville Municipal Code Section 10.28.030 requires such fines and penalties to be consistent with the schedule adopted by the County of Napa.
- E. Section 10.28.080 of Chapter 10.28 of Title 10 of the Yountville Municipal Code authorizes the Town Engineer to install and maintain parking space markings to indicate spaces adjacent to curbing where authorized parking is permitted and in any municipal parking lot; and
- F. California Vehicle Code section 22507 authorizes the Town by resolution to prohibit or restrict the stopping, parking, or standing of vehicles on certain streets or highways, or portions thereof, during all or certain hours of the day, which resolution becomes effective upon the placement of signs and markings giving adequate notice thereof; and
- G. Any violation of Chapter 10.28 of the Yountville Municipal Code, including, but not limited to, violations of parking restrictions in municipal parking lots, is subject to a civil penalty in addition to any other enforcement remedy available under law; and
- H. This Resolution strengthens the Town's parking enforcement capabilities by authorizing any peace officer or Town contracted parking vendor to remove parked vehicles that violate red curb markings, disabled accessibility markings, upon private property designated as "no-marking" which has signage displayed consistent with Vehicle Code section 22658, or in any area with posted notice designating the area as "no-parking" consistent with Vehicle Code section 22651(n); and
- I. The Town Council desires to establish parking restrictions pursuant to Title 10 of the Yountville Municipal Code and other applicable law.

- J. The design plans and specifications are complete and ready to be executed.
- K. Staff requests the Town Council approve and adopt the plans, specifications and working details, and authorize construction and installation of the parking improvements as described herein.
- L. This project is categorically exempt under Section 15302(c) Categorically Exempt per California Environmental Quality Act (CEQA) Guideline; Class 2 Replacement or Reconstruction.

Now therefore, the Town Council of the Town of Yountville does resolve as follows:

- 1) The Recitals above are true and correct and incorporated herein by this reference.
- 2) The following parking restrictions are hereby established:
 - a) Public parking in the right of way between Pedroni and Madison are posted for 3 Hour limit from 6 AM to Midnight Monday through Sunday including holidays.
 - b) Public Parking at Yountville Community Park on the South Side of Jackson Street at the Playground area is limited to 3 Hours parking 6AM to Midnight Monday through Sunday including holidays. Permits for events/parties could be issued for longer durations if needed/required.
 - c) Public Parking on the West side of Washington Street, South of California Street to Champagne Street is limited to 3 Hours parking during 6AM to Midnight Monday through Sunday including holidays.
 - d) Limousine and Bus parking is prohibited in Old Town and East of Ivy Court on Mulberry Street from Monday through Sunday including holidays.
- 3) EV Parking Limited to 4 Hours in EV Charging locations in the Public Right of way or Public Parking areas including public parking lots from Monday through Sunday including holidays.
- 4) The plans, specifications and working details are hereby approved and adopted, and construction and installation of the parking improvements is hereby authorized as described herein.
- 5) The Town Engineer is authorized and directed to install and maintain appropriate signs and markings in accordance with and to effectuate this Resolution.
- 6) The Resolution is hereby adopted and becomes effective and in full force immediately upon adoption.
