Renovations include the skilled nursing center to replace Holderman Hospital and there are also going to be efforts to modernize the facilities and service delivery in general. Four of five Council Members, Town Manager and Staff attended the Local Agency Formation Commission (LAFCO) of Napa County held February 5, 2017 in Town Hall Council Chambers, as Commission considered the draft municipal services review and Sphere of Influence (SOI) review submitted by the Town. The public comment period continues for one more month and hopefully the Town's request will be approved in April.
